

With regard to the personal data of our contract partners, the data protection regulations, in particular the General Data Protection Regulation (GDPR), are complied with. In the following, we inform you about the collection of personal data when entering into contracts.

1. Description, Purpose and Legal Basis of Data Processing

- 1.1 Personal data of our contract partners are collected, stored, processed and used by Heubach, insofar and as long as this is necessary for the execution of pre-contractual measures or the fulfillment of the contract. Any further collection, storage, processing and use of personal data will occur only to the extent required or permitted under a statutory provision, or if you have given us your express consent.
- 1.2 The implementation of pre-contractual measures and fulfillment of this contract, in accordance with Art. 6(1)(b) GDPR, requires, in addition to the name and VAT number of the company, the collection, processing and, *inter alia*, use of the name of the contact person, a billing and, if different, delivery address, as well as an e-mail address (hereinafter "personal data").
- 1.3 We are entitled – to the extent permitted by law – to transfer such personal data to third parties, insofar as and to the extent that this is necessary to carry out pre-contractual measures and to fulfill this agreement (such as shipping companies, invoicing) on the basis of Art. 6(1)(b) GDPR, or to fulfill a legal obligation under Art. 6(1)(c) GDPR.

2. Duration of Storage

We will delete the personal data of our contract partners at the latest at the end of the statutory retention period (Section 147(3) of the German Regulation on Taxation), that is, after the expiration of 10 years, starting from the date on which the contract is concluded.

3. Questions on Data Protection and Rights of Contract Partners

- 3.1 Our contract partners are entitled, under statutory provisions, to demand information from us about their personal data stored at any time. Under the statutory provisions, you also have the right to demand the rectification, blocking, restriction of processing and/or erasure or transmission of your data to a third party. If you have given us your consent to use your personal information, you may revoke it at any time with future effect. You also have the right to lodge a complaint with a supervisory authority.
- 3.2 Please direct your requests for information, rectification, erasure or blocking, as well as for exercising your right of revocation and/or right to object to Heubach in its capacity as the data controller:
